### **BASL Treasurer**

Elected by the membership. The Treasurer is one of three principal officers of the Association. The post holder can serve for up to three years and may be re-elected once.

The Treasurer has the following duties:

- To represent the Association in financial negotiations with third parties together;
- To oversee the collection and distribution of money on behalf of the Association and keep records of all transactions;
- To engage and supervise an accountant who will keep the books of the Association;
- To present the annual accounts, consisting of the profit and loss statement and balance sheet, to the Business Meeting;
- To present the current accounts to the Governing Board.

### **BASL BLTG Chair**

Elected by the membership. The post holder will serve for a period of up to three years and may be re-elected once.

The BLTG Chair is commissioned by the Governing Board to:

- To promote and facilitate the exchange of scientific information between clinicians, scientists and the diverse groups with an interest in liver transplantation;
- To foster multi-centre clinical and scientific studies within the UK;
- To promote education of health professionals and scientists with regard to liver transplantation;
- To promote public awareness of liver transplantation;
- To act as an advisor to national health authorities concerning liver transplantation, provision of clinical services and the need for research funding.
- To develop and promote standards of care in liver transplantation;
- To develop guidelines for the better management of liver transplantation.

## **BASL Services Lead**

Elected by the membership. The post holder will serve for a period of up to three years and may be re-elected once. The Services Lead supports the development and implementation of Clinical Standards and the provision of Clinical Services, including preparation and delivery of advice to national health authorities concerning liver diseases.

The Services Lead has the following responsibilities:

- To provide either a direct response, or a coordinated response on behalf of the President when NICE ask BASL for a positional statement on a new evaluation;
- To act as a formal deputy to the President for national HPB CRG related meetings, where the President cannot be in attendance them self;
- To help coordinate the writing of national position statements for the President where it relates to activities that align with clinical service standards;
- To provide representation for BASL at the BSG Quality Standards framework meetings along with the President and provide leadership and input in the implementation of these in relationship to liver disease;
- To help coordinate data collection for the President where it is needed in terms of national service delivery;
- To provide leadership and support to BASL to prevent unwanted variation in the delivery of liver clinical services through national based initiatives.
