Aim

The aim of the masterclass is to update practitioners on common infections of the liver concentrating on liver abscess and viral hepatitis and the management of infectious liver disease. A review of the current understanding of resistance to DAA will enable practitioners to guide appropriate management of viral hepatitis.
